1. Boats shall be a maximum of 20 feet in length. Maximum mast height is 20 feet.
2. Launching is permitted only at the designated sites. Boat ramp hours are posted at the Lake Lenape Ramp, 7:30 am till $1 / 2$ hour after sunset.
3. Boats not permitted to be docked as a registered Lake Lenape homeowner must be removed from the lake by one half hour after sunset.
4. Boats with engines of 9.9 horsepower or less are registered as a low-power boat. Boats with engines of 10 horsepower and above are registered as high-power boats.
5. Permits may be obtained at the Lake Lenape Boat House office, 6303 Old Harding Highway, Mays Landing, between the hours of 7:30 am and 5:00 pm seven days a week (609-625-8219).
6. The power boat application expires at the end of each calendar year; a $\$ 5.00$ processing fee is required. Make checks payable to the Atlantic County Treasurer.
7. All boats with motors must have a valid New Jersey Boat Registration.
8. Any operator of a vessel that is motorized in anyway must have a valid Boating Safety Certificate issued by the State of New Jersey, Division of State Police Marine Services Bureau or a comparable certificate if not a resident of NJ to operate upon Lake Lenape.
9. Operators of high-power boats shall demonstrate a driver's license with a boat operator's endorsement or a non-driver photo identification card with a boat operator's endorsement as required by New Jersey State Law.
10. Power Boats over 9.9 HP must carry at least $\$ 500,000$ of marine liability insurance. The certificate of insurance must show the certificate holder as "County of Atlantic, 1333 Atlantic Ave., Atlantic City, NJ 08401".
11. Boat owners and operators agree to indemnify and hold harmless the County of Atlantic, its elected officials, agents, servants and claims, actions, expenses, judgments, subrogation, other expenses or liability by reason of any real or alleged injury to any person arising out of or incidental to use of any water craft on Lake Lenape.
12. Maximum speed of any boat shall not exceed 40 MPH .
13. No powerboat shall operate within 200 feet of any swimming area. All boats shall operate to avoid danger and injury to all persons or manner of vessel, whether floating, mooring, anchored, or underway, to piers, wharves, bulkheads, or other waterfront construction, whether directly, or by the effect of the wave raised by the boat through its speed.
14. No person shall operate any vessel in a reckless or negligent manner. Boaters shall obey the directives of Park Rangers or authorized County representatives at all times.
15. All vessels are subject to Coast Guard Rules of the Road, and must pay heed to all regulatory buoys.
16. No person shall operate or permit another person to operate, a vessel while under the influence of drugs or alcohol.
17. No swimming or diving from boats.
18. Parasailing and operation of personal water craft (jet skis, etc.) is prohibited.
19. Launching inflatables is prohibited, unless being towed behind a ski boat.
20. Each boat is required by State law to possess all required safety equipment for vessels of that size classification, occupancy and intended use (example: skiing, fishing, rowing etc.) Each operator shall produce upon request of any enforcement official the equipment required.
21. Keep 100 ft . from the fish ladder between March $1^{\text {st }}$ and June $15^{\text {th }}$
